Report Highlights:

Korea's contracts for rice imports under the 2012 WTO Minimum Market Access (MMA) system allowed expanded opportunities for U.S. rice suppliers, while the U.S. table rice allocation increased by 46 percent over 2011. The United States won tenders for 50,825 MT or 31 percent of the total Global Quota of 162,778 MT. With a total of 100,901 MT, the U.S. garnered a 27% share of the 2012 MMA with contracts valued at US \$78 million.

General Information:

Overview:

The Korea Agro-Fisheries Trade Corporation (aT) completed the tendering process for the 2012 Minimum Market Access (MMA) commitments for rice on December 27, 2012. Korea purchased a total of 368,006 metric tons (MT) of rice from the United States, China, Thailand, Australia, Vietnam, India and Myanmar. The U.S. share was 27 percent, with contracts totaling 100,901 MT (milled) worth US\$78 million. The bulk of the U.S. contracts, roughly 67,605 MT, were for brown rice (equivalent to 60,845 MT on milled basis) with deliveries from June 2012 through April 2013, while the remaining 40,056 MT was for milled table rice with delivery dates from April 2012 through February 2013.

The U.S. Country Specific Quota (CSQ) totaled 50,076 MT. Additionally, the United States contracted to supply 50,825 MT or 31.2 percent of the total Global Quota (GQ) of 162,778 MT, followed by China with 49,911 MT or 30.7 percent, Vietnam with 45,400 MT or 28 percent, India with 11,642 MT or 7.2 percent and Myanmar with 5,000 MT or 3 percent on a milled basis.

Australia contracted to sell 9,030 MT under its CSQ for the first time in seven years, consisting of 4,858 MT of No. 1 grade medium grain for table purpose and 4,172 MT of No. 3 grade medium grain for food processing purpose.

The 2012 U.S. CSQ, totaled 50,076, consisting of 40,056 MT of table rice and 10,020 MT for processing. The U.S. table rice allocation increased by 46 percent to 40,056 MT compared to 27,473 MT in 2011. Meanwhile, the U.S. CSQ allocated to processing decreased by 56 percent from 22,603 MT in 2011 to 10,020 MT in 2012. In general, the increased U.S. table rice allocation is attributed to a redistribution of Chinese and Thai rice for table purpose, reflecting Korean consumers' response to imported rice. The pace of auctioning of table rice imported from China and Thailand has been very slow due to a lack of demand from Korean consumers.

The average contracted price for U.S. #1 table rice was \$770.28/MT, down approximately 7 percent from the previous year. Additionally, U.S. #3 table rice averaged \$693.99/MT, down 7.6 percent from the previous year's contracted price. Chinese #1 table rice prices were down one percent to \$928/MT on average, while Thai #1 table rice prices decreased to \$668.26/MT, down 12 percent from the previous year respectively.
