2014 Tariff-Rate-Quota (TRQ) Fill Rates Show Positive Trade Trend


Report Highlights:

Under the May 2012 United States-Colombia Trade Promotion Agreement (CTPA), certain commodities are imported into Colombia under TRQs. The Colombian National Office of Taxes and Customs (DIAN) released the 2014 TRQ fill rates. According to DIAN import data, fill rates for all TRQ commodities demonstrated a more dynamic trade trend from the year before: five commodities were fully subscribed compared to only one in 2013.

General Information:

In 2014, TRQ fill rates demonstrated a positive trade trend into the second full year of the CTPA. The graph below illustrates the notable increase in TRQ fill rates from 2012 to 2014. The TRQs for rice and chicken-leg-quarters are managed under an Export Trading Company (ETC) that holds periodic auctions for the right to export specific volumes of product. The other commodities are managed under a first come/first serve basis with DIAN monitoring the calendar year volume of imports under quota.

In 2014, rice, yellow corn, white corn, soybean oil and milk powder completely filled the allocated quotas. Commodities with notable increases in the quota fill rate year-on-year were chicken-leg-quarters, ice cream, and cheese.
