2015 Korea's Adjustment and Quota Tariffs Schedule

Report Highlights:

Korea recently announced revisions made to the 2015 tariff schedule in order to stabilize domestic consumer prices for certain agricultural products; most of which are used for livestock feed production, mushroom growing, and aquaculture farming (Beet-pulp, Oil cake of cotton seeds, Cotton seed hulls and young eels).

Adjustment Tariffs & Voluntary TRQs Announced for 2015

On December 23, 2014, the Ministry of Strategy and Finance (MOSF) announced an updated list of adjustment tariffs (Table I) and voluntary tariff rate quotas (TRQs) for certain agricultural, forestry and fishery products (Table II). These revisions (I & II) are effective through calendar year 2015. These changes are expected to facilitate continued imports of U.S. agricultural products, particularly feed grains and food ingredients. The most notable changes are listed below.

In the 2015 schedule, the Republic of Korea Government (ROKG) lowered adjustment tariffs for four commodities (frozen croaker, frozen Alaskan Pollack, live eels and red pepper paste) because ROKG determined protection of these domestic products was unnecessary. The ROKG also delisted "live croaker" for 2015 in consideration of the fact that there are no aquaculture farms for live croaker in Korea and croaker caught in the domestic sea is an expensive sashimi dish rather than a staple of Korean consumer diets.

Since international prices for agricultural raw materials have decreased substantially the ROKG has reduced the number of commodities with tariff quotas in order to stabilize domestic consumer prices. Thus, "rye for seed", "malting barley" and "malt for beer brewing" has been delisted accordingly.

ROKG instituted voluntarily tariff rate quota (TRQ) commodities to support and to increase the competitiveness of the domestic agricultural and livestock industries, which are facing more and more pressure as FTA agreements have allowed imports to challenge domestic products. ROKG took the following measures for the commodities listed:

- Feed commodities: whey, manior pellets, unhulled barley, oats (Korea depends entirely on imports of these commodities).
- Agricultural and aquaculture commodities: Korea established a quota for beet-pulp, cotton seed oil cake for mushroom growing and young eels for aquaculture in order to mitigate high prices for imports of these items.
- Refined sugar: Korea increased the quota from 40,000 MT to 90,000 MT with a 5 percent duty to stabilize domestic retail prices.
