Report Highlights:

On November 4, 2022, the Korea Agro-Fisheries & Food Trade Corporation (aT) announced the results of the 2022 U.S. orange tariff rate quota (TRQ) allocations. Korea switched to a new license allocation system this year, replacing the import rights auction process used in prior years. A key piece of the new allocation system is that 80 percent of the total TRQ is reserved for importers with historical import volumes, while the remaining 20 percent is reserved for new importers. This report contains a translation of Korea's announcement detailing the implementation process for the new allocation system, as well as a list of the companies that received import volume allocations for the 2022 U.S. orange TRQ.





Note: The following is an unofficial translation of the original Korean text published by the Korean Ministry of Agriculture, Food and Rural Affairs (MAFRA), provided here for informational purposes.

NOTICE: PLAN FOR 2022 ALLOCATION OF ORANGE TRQ UNDER KORUS FTA AND EU FTA

We hereby announce the plan for the 2022 orange tariff rate quota (TRQ) allocation under the U.S. - Korea Free Trade Agreement (KORUS FTA) and European Union (EU) FTA as follows. We ask for your understanding for the delay in allocating the TRQ. The delay was due to the legal consultations, case study, consultations with Embassies, etc. that were needed to prepare the allocation standard caused by the change in import control method (public auction → allocation). We plan to increase the amount available for advance TRQ allocation requests (available only to companies with historical import records) up to 50 percent of the three-year average amount that was imported under the TRQ recommended amount. We hope this information will help you in making your business decisions.





APPLICATION METHOD



- * For details procedures for applying, please refer to the aTBid Customer Support [Manual for TRQ Import Recommendation].
- * Applications accompanied with an authentication certificate must be used in applying for the allocation and registration of the authentication certificate under the menu of "My bidding information → Registration of official authentication certificate" is mandatory.
- * Sites for receiving authentication certificate: Korea Information Certificate Authority, Inc., Koscom, Korea Financial Telecommunications & Clearing Institute, Korea Electronic Certification Authority, Korea Trade Network.
- (2) New applicants: Application for new applicants must be submitted by November 1, 2022 (Tuesday). (Applications or changes to the application this notice cannot be made after the deadline.)



- * The password and ID can be changed after logging in for the first time.
- (3) When information of the member company needs to be updated: Please send the business registration form via email to the person in charge at aT.



□ Advance allocation requests

Companies that have historical records of importing TRQ under the KORUS FTA and EU FTA during the period 2019-2021 can apply and receive import recommendations of up to 50% of the average import volume made under the TRQ during the period 2019-2021 prior to the announcement of the 2022 allocation. The amount that these companies receive as an advance recommended allocation shall be subtracted from the final allocation amount. * The applicants must meet the qualification for receiving an allocation in 2022 at the time that they apply.


*(2022) This measure to increase the amount for pre-recommendation is due to the delay in publicizing the allocation notice.

• Application method: Submit the shipping documents and amount of TRQ requested to the person in charge (Contact point provided in section VII of this notice) after applying for the allocation.

The validity period will be calculated form the date that it is issued. The import recommendation can be reissued if the extension request is submitted.

RETURN OF IMPORT RECOMMENDATION

When giving up the total or a portion of the import recommendation amount, or when the validity period has expired, or when it is impossible to import due to other reasons, the import recommendation form must be immediately returned to aT. (Appendix form 2)


□ OBLIGATION OF COMPANIES ALLOCATED THE TRQ

- o Companies that have been allocated the import entitlement must import at least 95 percent of the amount allocated for each product and each company by February 28, 2023. If the import is not utilized, the company will be excluded from the first round of allocation in the following year unless the company can provide a justifiable reason for failure to utilize the allocation.
 - ** The Import Report must be submitted by February 28, 2023 and must clear customs (import declaration must have been accepted) by March 31, 2023.

☐ SURVEY AND INVESTIGATION OF WHETHER IMPORTS HAVE ACTUALLY BEEN CARRIED OUT

- In accordance with the relevant provisions provided in the "Survey and reporting of actual implementation (MAFRA Notice)," it is requested that the applicant agree to sharing the information provided by the Korea Trade Statistics Promotion Institute.
- * Article 23 of KORUS FTA and Article 21 of Korea-EU FTA.
- * Method for providing agreement to share information shall be provided at a later date.

O Procedure for Self-Check of Import Implementation: Need to check to see if import implementation has been finished and make corrections within the date that the import declaration has been accepted (Up to March 31, 2023).



Note: The final implementation rate will be based on the actual imports made within the date that the import declaration has been accepted (March 31, 2023). If there are errors, the company should request for corrections to the person in charge at aT and it is impossible to make corrections after the deadline.

Sanctions For TRQ Awarded Companies

- □ The company with TRQ allocated must use the TRQ for the recommended purpose. In case of a violation, aT cancels the issuance of the recommendation letter and imposes sanctions in accordance with the relevant laws.
- □ If one or more of the representative, address, and phone number of the applicant company is duplicated, it is considered as a false or fraudulent application and the TRQ will be allocated to only one of the relevant companies. A company that falls under the above may file a complaint for obstruction of the execution of official duties and obstruction of business, and if a false or fraudulent application is proven as a result, the existing TRQ recommendation letter can be canceled and the allocated import rights can be returned.
- □ Matters not specified in this announcement follow the notification of the Ministry of Agriculture, Food and Rural Affairs (MAFRA) and detailed instructions of aT.

FTA TRQ [Orange] Distribution Standard for Import Rights

1. TRQ Distribution Standard

- (1) In case the application volume is less than the allocation volume:
- Allocation of the total volume of application.
- (2) In case the application volume exceeds the allocation volume:
- \circ (1st round/newcomer) Up to 18 tons will be allocated on a first-come, first-served basis within 20% of the total quota.
- If the volume requested on a first-come-first-served basis exceeds 20%, the excess volume will not be allocated.
- * Example) When the total quota is 3,360 tons and 38 new companies apply for it, it will exceed 672 tons, which is 20% of the quota, so the 38th applicant will not be allocated on a first-come, first-served basis, and the remaining volume is included in the allocation of existing companies.
- (Second round/Existing companies) The remaining volume after the first allocation and 80% of the total quota is added up to the existing companies based on the past import performance of the last 3 years.

Past Import Performance:

(2022 – 2024) FTA TRQ [orange] import performance for the relevant country for the past 3 years

(2025 -) Total import performance (FTA TRQ implementation performance + tariff paid volume other than TRQ) during the FTA TRQ implementation period (September to February of the following year) for the last 3 years

At least, 18 tons will be guaranteed for TRQ allocation to existing companies

- * Existing companies: Companies that have FTA TRQ import recommendations for oranges originating from the pertinent country for the past 3 years
- * Newcomers: Companies that have no FTA TRQ import recommendation for oranges originating from the pertinent country for the past 3 years
- It means the last 3 years from the current year. In other words, in 2022, the standard for the last three years will be 2019-2021.

2. Required Documents for TRQ allocation

- (Documents to be submitted) 1 copy of Certificate of Business Registration (issued after 10/6/2022).
- * Other documents (TRQ application, consent to use of personal information, memorandum of implementation, etc.) are replaced by electronic application.
- ° (Check past import performance) No need to submit an import performance certificate such as a report certificate when agreeing to provide information on import performance in connection with the Korea Trade Statistics Promotion Agency. * Detailed procedure: [Reference 2]

- * (Receipt for TRQ return) According to Article 19 (Measures to promote the implementation rate) of the detailed guidelines for imports recommendation of our corporation(aT), the expected unfulfilled quota volume must be returned 6 months before the end of the TRQ implementation period. But the orange has only six-month implementation period, so it must be returned 3 months before the end (November) of TRQ implementation period.

Distribution criteria may be changed in the future according to government policies and agreements with pertinent countries.
