China Cuts Import Tariffs for 730 Commodities on January 1

Report Highlights:

On January 1, 2012, China will adopt temporary duties on a total of 730 commodities, including agricultural machinery, fertilizers, animal feed, infant formula, and frozen seafood. According to the Ministry of Finance, the move is largely aimed at boosting imports and reducing China's high inflation rate.

General Information:

On December 15, 2011, the Ministry of Finance announced on its web site that the Chinese Government will temporarily adopt lower import tariffs for a total of 730 commodities as of January 1, 2012. Once this measure is implemented, the average tariff will be 4.4 percent, which is 50 percent lower than the most-favored-nation (MFN) rate. According to the Ministry announcement, the purpose of this move is to increase imports to meet demand and reduce China's inflation rate. Local media report that lower tariffs on energy and natural resources, as well as inputs such as fertilizer, will have a cascading effect helping to reduce production costs for domestic industries that rely heavily on the world market for inputs, and eventually cooling down the high inflation rate. Local newspapers report that boosting imports has been upgraded to a national strategic policy, although there are reportedly disagreements between different ministries and state departments on specific measures.

The 730 commodities fall into five categories: 1) energy and resource products, including coal, coke, petroleum products, marble, granite, natural rubber, rare earth, copper, aluminum, and nickel; 2) key equipment and parts for emerging strategic industries such as high-tech equipment manufacturing, new generation of information technology, and automobiles using new energy sources; 3) agricultural production materials, including high-powered tractors, large harvest machinery, dairy processing equipment, ingredients for agriculture chemicals, fertilizer, and animal feed; 4) products for daily use, including frozen seafood, special infant formula, infant food, preparations for the care of skin, preparations for hair-dressing, table ware and chicken ware; and, 5) public health and sanitation products, including vaccine, serum, artificial cochlear, and X-ray film.

The tariff reductions should facilitate imports of some but not all agricultural products from the United States. For example, frozen plaice, for which the United States is the top supplier (\$203 million in January-November, 2011), is covered by the tariff reduction list, but frozen pacific salmon, the top US seafood export to China (\$241 million in January-November, 2011), is not included. Other agricultural exports covered by the tariff reduction, for which the U.S. is the top supplier, include whey and modified whey (\$159 million in January-November, 2011), food preparations (infant formula) (\$128 million in January-November, 2011), and feed preparations (\$36 million in January-November, 2011). Imports of pistachios, for which the United States is also the major supplier, may not be affected as China adopted a temporary tariff of five percent on pistachios in 2008 and has not changed the rate since then.

The Ministry of Finance did not indicate how long the temporary duties will stay in place. The reduced tariffs, however, will apply to all trading partners, unless they have entered a bilateral trade agreement with China, which may provide a more favorable tariff rate.
