Report Highlights:

On December 20, Taiwan completed a tender for 20,000 tons of the U.S. rice. The rice was awarded to one bidder at NT\$20,645/mt or \$681.35/mt. (Exchange rate: \$1 to NT\$30.30). This tender completes Taiwan's 2011 rice country specific quota (CSQ) tendering obligations and successfully fills the 2011 U.S. rice CSQ.

General Information: Summary

Taiwan completed the 2011 rice Country Specific Quota (CSQ) tenders after successfully tendering GF4-100-185 for 20,000 tons of U.S. CSQ on December 20.

Results of the Tender GF4-100-185 for 20,000 tons of U.S.-origin 2011 Crop Medium/Short Grain Brown Rice

On December 20, Taiwan completed this rice tender during the first round of bidding. One bidder out of eight who participated in the bid was awarded the entire 20,000 tons at price of NT\$20,645mt or \$681.35/mt (Exchange rate: \$1 = NT\$30.30). All tendered/contracted rice must be delivered to the AFA designated warehouses during April 1-June 30, 2012.
