### **Report Highlights:**

Croatia imports about 50 percent of its dried bean consumption. In 2010, Croatia imported 4,693 MT of dried beans valued \$5.7 million, mostly from China and Canada. The most interesting products for U.S. suppliers include: cranberry beans (depending on a price could be replaced with a pinto bean), dark red kidney beans, and white beans.

## **General Information:**

#### **Market Overview**

In 2010, Croatia produced 5,277 metric tons (MT) of beans, of which only 1,401 MT was produced commercially. The remainder was produced in backyard gardens for home consumption. The lack of significant commercial production is due to small field size and the inability to realize economies of scale that would ensure farmers a good return from bean production. In addition, bean production has not been subsidized for a number of years. Assuming Croatians consume 2 kilograms of dried beans annual, total demand is at least 9,000 MT, which indicates there is significant amount of dried bean imports.

#### **Imports and Exports**

In general, Croatia is an importer of pulses. In 2010, pulses imports reached \$7.2 million (5,763 MT), mostly from China and Canada. Regardless of the global economic crisis, imports of pulses remained stable (inelastic). For the past three years, the import value of pulses ranged from \$8.5 to \$7.3 million. Croatia exports negligible quantities of pulses.

The most interesting segment of the Croatian pulse market is dried beans. In order of importance, the most interesting dried beans are: cranberry beans (depending on a price could be replaced with a pinto bean), dark red kidney beans, and white beans. In 2010 Croatia imported 4,693 MT of dried beans, valued at \$5.7 million, mostly from China and Canada.

# Tariffs and VAT

The value added tax (VAT) on all products is 23% at present. MFN tariffs for beans are 13%. They are lower or zero for some countries that have bilateral agreements with Croatia and for the EU (Stabilization and Accession Agreement). Tariffs vary depending on a product, season and from year to year thus the most current tariff rates can be found at:

As an EU-candidate country, Croatia complies with all relevant EU legislation and all beans that is eligible to be exported to the EU market, is eligible to be exported to Croatia.
