New draft SPS amendments to the current rules of domestic veterinary certification were posted on the Russian Government website for public review at <http://regulation.gov.ru/>:

In particular, the amendments update the list of products that will be subject to domestic veterinary certification based on the Unified List of Products Subject to Veterinary Control (Surveillance) approved by the resolution of the Customs Union Commission No. 317 of June 18, 2010.

According to the regulation.gov.ru, it is planned that the amendments will come into effect by September 1, 2015.

**Order of the Ministry of Agriculture of the Russian Federation
No. 281 of July 17, 2014**

**“On Approval of the Rules of Handling the Execution of Veterinary Accompanying Documents
and Procedures for the Execution of Veterinary Accompanying Documents in Electronic Format”**

(as amended by orders of the Ministry of Agriculture of Russia No. 70 of February 20, 2015, and No. 78
of February 26, 2015)

For the purposes of improvement of regulations in the field of veterinary medicine, I hereby order to:

1. Approve the attached Rules on handling the execution of veterinary accompanying documents (Attachment N 1).

2. Approve the attached Rules on the execution of veterinary accompanying documents in electronic format (Attachment N 2).

2.1 Approve the attached List of regulated products listed in the common list of products subject to veterinary control (surveillance) approved by the resolution of the Customs Union Commission No. 317 of June 18, 2010 “On the application of veterinary and sanitary measures in the Customs Union,” for which veterinary accompanying documents shall be executed as of August 1, 2017.

3. Recommend agencies and institutions of the Russian Federation State Veterinary Service system to create a technical possibility of drawing up veterinary accompanying documents in electronic format by August 1, 2017.

Establish that veterinary accompanying documents must be executed in electronic format by the bodies and institutions within the system of the veterinary service of the Russian Federation when technically possible.

Establish that the execution of veterinary accompanying documents for regulated goods listed in the Common List of Products subject to veterinary control (surveillance) approved by the resolution of the Customs Union Commission No. 317 of June 18, 2010 “On the Application of Veterinary and Sanitary Measures in the Customs Union” and specified in Attachment N 3 to the present Order, begins on August 1, 2017.

4. Declare the following orders of the Ministry of Agriculture of Russia to be no longer in force:

N 422 of November 16, 2006 “Concerning Approval of the Rules on Handling the Execution of Veterinary Accompanying Documents” (registered by Ministry of Justice of Russia on November 24, 2006, registration N 8524);

N 393 of August 14, 2007 “Concerning the Introduction of Amendments to the Order of MinAg of Russia from 16.11.2006 N 422” (registered by Ministry of Justice of Russia on September 12, 2007, registration N 10130);

N 98 of March 19, 2008 “Concerning the Introduction of Amendments to the Order of MinAg of Russia from 16.11.2006 N 422” (registered by Ministry of Justice of Russia on April 22, 2008, registration N 11561);

N 522 of December 4, 2008 “Concerning the Introduction of Amendments to the Order of MinAg of Russia from November 16, 2006 N 422” (registered by Ministry of Justice of Russia on December 30, 2008, registration N 13041);

N 176 of May 5, 2009 “Concerning the Introduction of Amendments to the Order of MinAg of Russia from 16.11.2006 N 422” (registered by Ministry of Justice of Russia on June 4, 2009, registration N 14030);

N 84 of March 19, 2010 “Concerning the Introduction of Amendments to the Order of MinAg of Russia from November 16, 2006 N 422” (registered by Ministry of Justice of Russia on April 13, 2010, registration N 16875).

5. Declare paragraph 1 of the Order the Ministry of Agriculture of Russia N 185 of June 5, 2014 “Concerning the Introduction of Amendments to Certain Regulatory Acts of MinAg of Russia” (registered by Ministry of Justice of Russia on July 16, 2014, registration N 33124) to be no longer in force.

6. State Secretary - Deputy Minister of Agriculture A.V.Petrikov shall take responsibility for the implementation of the present Order.

7. The Order shall enter into force on September 1, 2015.

**RULES
OF HANDLING THE EXECUTION OF VETERINARY
ACCOMPANYING DOCUMENTS**

1. The present Rules have been drafted to ensure veterinary and sanitary safety of regulated products and animals subject to veterinary control (surveillance) (hereinafter – regulated goods), to confirm that the territories where regulated goods are produced are free from contagious animal diseases including diseases common to man and animals, and to provide traceability of regulated goods during their transportation across the territory of the Russian Federation. The Rules shall establish procedures for handling the execution of veterinary accompanying documents in the Russian Federation.

2. Veterinary accompanying documents (veterinary certificates, veterinary attestations, veterinary statements) describing territorial origin and species of animals, veterinary and sanitary conditions of the accompanied regulated cargo, epizootic conditions at the point of departure, and enabling to identify the regulated goods shall be issued for regulated goods listed in the Common List of Goods subject to veterinary control (surveillance) approved by the resolution of the Customs Union Commission No. 317 of June 18, 2010 “On the Application of Veterinary and Sanitary Measures in the Customs Union”.

3. Veterinary accompanying documents shall be issued for the following instances:
production of a batch of regulated products (excluding production for home consumption);
movement (transportation) of regulated goods;
transfer of ownership of regulated goods (excluding transfer (sales) of regulated goods to a buyer for personal, family, home or other non-business related consumption).

4. Veterinary accompanying documents shall be issued and released within one working day on condition that there is no need to perform lab tests on regulated goods, and where this might be necessary – within one working day after the tests are completed.

An official who has made a decision to send regulated goods for lab testing must provide a written justification of such decision at the request of an individual who applied for the veterinary accompanying document.

In case regulated goods are exported, VPSS territorial units shall issue veterinary certificates on the basis of information about the epizootic situation at the place of origin/dispatch of regulated goods, and lab tests performed in the labs certified for such purpose.

5. Veterinary accompanying documents shall be issued both in hard copy and in electronic format <1>. Veterinary accompanying documents shall be issued using the State Information System (hereinafter – GIS).

<1> Veterinary accompanying documents shall be issued in electronic format when technically possible.

In case the veterinary certificate is issued in electronic format, the shipping documents (in Attachment to the shipping documentation) shall reflect the veterinary certificate number and/or the matching two-dimensional matrix bar code generated by GIS.

6. In case veterinary accompanying documents are issued in hard copy, they are issued on blank forms accounted for by GIS.

Hard copies of blank forms of veterinary accompanying documents and their blank stubs are strictly accountable documents and have at least 5 security features (class “A” printing product) including: color; watermarks; typographic number; serial number of the administrative-territorial division (republic, krai, oblast); Guilloche frame of a positive image; microtext along the Guilloche frame perimeter.

A series of three digits and a sequence number shall be drawn on the blank forms of veterinary accompanying documents.

Blank forms of veterinary accompanying documents issued by VPSS territorial units shall be numbered according to the following combination of digits: the first digit of the series – 1, second and third digits of the series – the federal code of VPSS territorial unit in accordance with Attachment N 2 to the present Rules, and “N” character followed by the document serial number.

Blank forms of veterinary accompanying documents issued by institutions subordinate to the government bodies of the constituent entities of the Russian Federation in the field of veterinary medicine shall be numbered according to the following combination of digits: the first digit in the series is 2, second and third digits in the series is the region’s code in accordance with Attachment N 2 to the present Rules, character “N” shall be followed with the document serial number.

Blank forms of veterinary accompanying documents issued by veterinary (veterinary and sanitary) services of the federal executive authorities in the field of defense, internal affairs, execution of sentences, state protection and security shall be numbered according to the following combination of digits:

the first digit in the series:

federal executive authority in the field of defense - 3;

federal executive authority in the field of internal affairs - 4;

federal executive authority in the field of execution of sentences - 5;

federal executive authority in the field of state protection - 6;

federal executive authority in the field of security - 7;

second and third digits in the series is the region’s code in accordance with Attachment N 2 to the present Rules, character “N” shall be followed with the document serial number.

Numbers of the administrative and territorial division of the Russian Federation shall be used to issue veterinary accompanying documents (Attachment N 2 to the present Rules).

7. When veterinary accompanying documents are issued in hard copy, the following forms are used: forms N N1, 2, 3, 4, ~~6.1, 6.2, 6.3~~, 5a, 5b, 5c, 5d, 5e, 5f, 5g, 5h, 5i, 5j, 5k, 5l (Attachment N 1 to the present Rules).

Institutions subordinate to the executive bodies of the constituent entities of the Russian Federation in the field of veterinary medicine and also veterinary (veterinary and sanitary) services of the federal executive authorities in the field of defense, internal affairs, execution of sentences, state protection and security shall issue veterinary attestation forms N N 1, 2, 3 and veterinary statement forms N 4.

VPSS territorial units shall issue veterinary certificate forms N N5a, 5b, 5c, 5d, 5e, 5f, 5g, 5h, 5i, 5j, 5k, 5l, ~~6.1, 6.2, 6.3~~.

Veterinary attestation forms N N1, 2, 3 shall be issued for production, circulation, and transportation of regulated goods outside the district (city) limits throughout the territory of the Russian Federation; veterinary attestation forms N 4 – for production, circulation, and transportation of regulated goods within the district (city) limits.

Regulated goods imported to the Russian Federation shall be accompanied by veterinary ~~certificate forms N 6.1, 6.2 and 6.3~~ certificates, issued by Rosselkhoznadzor electronically in accordance with the unified forms of veterinary certificates, approved by resolution of the Customs Union Commission No. 317 of June 18, 2010 “On the application of veterinary and sanitary measures in the Customs Union” during their transportation across the territory of the Russian Federation from the place of customs clearance to the place of destination, during their redirection between the constituent entities, and other specified cases.

Regulated goods shall be accompanied by veterinary certificate forms N 5a, 5b, 5c, 5d, 5e, 5f, 5g, 5h, 5i, 5j, 5k, 5l when exported from the territory of the Russian Federation.

Veterinary attestation form N 1 shall be issued for live animals and biologic objects.

Veterinary attestation form N 2 shall be issued for products of animal origin.

Veterinary attestation form N 3 shall be issued for technical raw material, feed and biological waste.

During transportation of leather and fur, veterinary statement form N 4 shall be issued regardless of the presence of brands, however tagging of hides is mandatory.

~~Veterinary certificate form N 6.1 shall be issued for live animals, genetic material including embryos, egg cells, semen, impregnated roe, and hatching eggs.~~

~~Veterinary certificate form N 6.2 shall be issued for products of animal origin.~~

~~Veterinary certificate form N 6.3 shall be issued for technical raw material and feed.~~

Veterinary certificate form N 5a shall be issued for slaughter, pedigree and other animals, poultry, bees or their brood exported from the Russian Federation.

Veterinary certificate form N 5b shall be issued for fodder grain or other plant products for the livestock industry exported from the Russian Federation.

Veterinary certificate form N 5c shall be issued for pedigree material (e.g. semen from sires, embryos, hatching eggs, and roe) exported from the Russian Federation.

Veterinary certificate form N 5d shall be issued for milk and dairy products exported from the Russian Federation.

Veterinary certificate form N 5e shall be issued for meat and meat products from domestic or wild animals exported from the Russian Federation.

Veterinary certificate form N 5f shall be issued for raw material of animal origin exported from the Russian Federation.

Veterinary certificate form N 5g shall be issued for honey and bee products exported from the Russian Federation.

Veterinary certificate form N 5h shall be issued for biological raw material intended for the production of drugs used in veterinary medicine (e.g. animal blood and its fractions, animal organs and tissues, cultures of microorganisms), zoology, anatomy and paleontology collections or samples exported from the Russian Federation.

Veterinary certificate form N 5i shall be issued for fish, crustaceans, shellfish, aquatic animals, and other commercial species and processed products exported from the Russian Federation.

Veterinary certificate form N 5j shall be issued for game trophies of wild animals, birds, fish, reptiles, as well as their parts and derivatives exported from the Russian Federation.

Veterinary certificate form N 5k shall be issued and released for poultry table eggs and egg powder exported from the Russian Federation.

Veterinary certificate form N 5l shall be issued for fish, crustaceans, shellfish, aquatic animals, other commercial species and processed products exported from the Russian Federation to the European Union.

8. Hard copies of completed stubs of veterinary accompanying documents and/or information in electronic format in GIS shall be kept for at least 3 years by bodies and institutions that issued the veterinary certificates. In case the shelf life of regulated goods is longer than 3 years, hard copies of completed stubs of veterinary accompanying documents and/or information in electronic format in GIS shall be kept throughout the shelf life of regulated goods.

9. Veterinary accompanying documents shall be valid:

when processing paperwork for the manufactured batch of regulated products – from the moment the paperwork is issued and before their expiration date and time period allowed for their sales and storage;

when processing paperwork for the batch of regulated products in transit - from the moment the paperwork is issued until the end of transportation;

when processing paperwork for the animals – within 5 days from the date of issuance until the end of transportation and/or sales.

During transportation of up to 5 heads of animals, list with their names and (or) number (for commercial livestock), as well as sex, breed, age (for pedigree livestock) shall be given in the corresponding table of the veterinary accompanying document or in the “Special notes” field of the veterinary accompanying document issued in hard copy.

During transportation of more than 5 heads of animals, the inventory indicating names and (or) number (for commercial livestock), as well as sex, breed, age (for pedigree livestock) attested by the seal of the institution that issued the document shall be attached to the veterinary accompanying document.

10. Veterinary accompanying documents issued in hard copy that were completed in different ink or handwriting, with corrections, unclear stamp imprint or without any stamp, signature or full title description, name and initials of the expert who had signed the veterinary certificate, without the required complete set of information including the date of issuance, and also copies of documents shall be considered invalid.

11. Bodies and institutions of the Russian Federation State Veterinary Service system shall issue veterinary accompanying documents.

12. During transportation of regulated goods between the constituent entities of the Russian Federation, the “Special notes” field of the veterinary attestation shall reflect the number and date of the authorization received from the head of the executive authority of the constituent entity of the Russian Federation in the field of veterinary medicine, as well as the number of the veterinary accompanying document that accompanied the regulated goods to the point of arrival.

During transportation of regulated goods through the territory of the Russian Federation intended for export from the territory of the Russian Federation, the “Special notes” field of the veterinary attestation shall reflect the VPSS permit number and date in accordance with the requirements stipulated by the laws of the Russian Federation on veterinary matters.
