Report Highlights:

The 2014 fresh deciduous fruits crop estimates in the Czech Republic describe the amount and quality of fruits as very satisfactory. Apple crop from the production orchards will reach 122,959 MT and for the pear crop 3,813 MT.

General Information:

Production

According to the latest estimates prepared by the Central Institute for Supervising and Testing in Agriculture in Brno and the Fruit Growers' Union, the apple crop from production orchards will reach 122,959 MT and for the pear crop 3,813 MT. This apple crop estimate exceeds the five year average by 9 percent. Some of the commercial fruit growers, mainly from southern Bohemia say it is the best apple crop in 20 years.

Quality of fruits is very good as well, as the occurrence of hailstorms was very low. Although the weather conditions in general were rather favorable, in some regions fruit trees suffered some damage during flowering due to the spring frosts.

The overall state of orchards in the Czech Republic is not ideal. Area will drop as older trees fall out of production. Total area and production data below refers to commercial orchards only, producing for both the fresh and the processing markets.

There are about fifteen main varieties of apples produced commercially in the Czech Republic. The dominant varieties are:

Consumption

According to the Czech Ministry of Agriculture's Situation and Outlook Report, per capita fruit consumption in the Czech Republic averaged 82 kg in 2012. Out of this, 34.5 kg represent southern fruits. Apples account for 20 kg per capita and pears only 3 kg. Approximately 40 thousand MT of apples were used in the processing industry.

Prices

The biggest challenge for Czech fruit growers in the current 2014/15 marketing year is the prices. As a result of the Russian import ban and a very good apple crop in the European Union, apples prices are hitting their minimum. The initial fear of the industry was that the Czech market would become flooded with Polish apples. According to Czech industry representatives, Polish producers are reportedly able to sell to the retail chains at prices that are lower than the production costs of Czech growers. This influx of Polish apples did not materialize.
