CIRCULAR

In continuation to the ease of doing business, Directorate of Plant Protection, Quarantine & Storage (DPPQS) has initiated the issuance of e- phyto (Digital Phyto-sanitary Certificate) to all the countries. The decision came into effect from 15-06-2017. All the Plant Quarantine stations under the administrative control of DPPQS have been directed to issue e- phyto with immediate effect. All the PSC signing authorities are also directed not to stamp and sign the e-phytos. The intimation to all the National Plant Protection Organizations (NPPOs) has been conveyed by NPPO-India through e-mail on 13-07-2017.

All the Plant Quarantine station in- charges are therefore asked to give a wide publicity to this circular.
