Japan Announces Decisive Additional Dairy Imports

Report Highlights:

On Thursday, May 28, 2015, the Japanese Ministry of Agriculture, Forestry, and Fisheries (MAFF) announced plans to import 10,000 metric tons (MT) of butter and 5,000 MT of non-fat dry milk (NFDM) in Japanese fiscal year (JFY) 2015. Japan's Agriculture and Livestock Industries Corporation (ALIC) will import these products in addition to Japan's required JFY 2015 current access import volume, most of which has already been allocated to butter (2,800 MT), NFDM (10,000 MT), and whey (2,500 MT). Japan has conducted additional dairy imports in five out of the last eight years.

General Information:

Earlier in 2015, MAFF announced that it would wait until May to determine the need for imports in excess of current access commitments.¹ Days after J-Milk (the national industry association representing Japanese dairy producer cooperatives, dairy product manufacturers and merchandizers of milk and dairy products) released its annual production estimates, on May 28, 2015, MAFF announced that additional imports would be required in JFY 2015 in order to ensure a "stable supply" of butter during the winter holidays (Japan's peak consumption period) and to prepare for unexpected contingencies that could negatively impact production prospects (e.g. a hotter than average summer, as occurred in 2014, reducing the volume of fluid milk for processing).² Announced ALIC dairy import volumes for JFY 2015 are listed in the table below.

The additional import volumes announced by MAFF reflect the continuing supply deficit of fluid milk for processing use as well as the significant public criticism that MAFF suffered this past winter when butter was noticeably absent from grocery store shelves. While MAFF estimates of total butter consumption in JFY 2014 were fairly accurate, the tender timeline was not properly synced with consumption patterns, which, combined with reported hoarding by small businesses, led to the average consumer's experience of a butter shortage.

Last winter's negative public reaction was the likely impetus for ALIC creating a new tender category for smaller packages of 1-5 kg in JFY 2015.³ This category is intended to improve wholesale

¹ As a result of the Uruguay Round of GATT/WTO negotiations, Japan is obligated to import 137,200 MT (on a milk equivalent basis) of designated dairy commodities, including: nonfat dry milk, butter, butter oil, dairy spread, whey and modified whey for food use. ³ The new tender category specifies two delivery options: bulk butter to be repackaged into 1-5 kg packages at domestic factories after importation; and direct importation of 1-5 kg packages. Typically, ALIC tendered butter is delivered in 10 kg, 15 kg, 20 kg or 25 kg packages.

distribution to the numerous smaller scale bakeries and confectionary shops that were reportedly buying butter from retail shelves last winter. It is notable that this specific tender category was initially created as a 280 MT 'pilot program' within the 2,800 MT JFY 2015 current access butter tenders (announced in January 2015), and then expanded to 2,000 MT (out of the 10,000 MT total) of the additional butter import volume before the 280 MT had even been delivered. In addition, MAFF and ALIC have taken further steps to prevent another consumer butter crisis in JFY 2015, by increasing the frequency of its market supply-demand assessments and by accelerating the delivery timeline for tendered butter to ensure that it arrives well ahead of the peak consumption period (typically October through December).
