Report Highlights:

In response to market conditions, including recently revised market access for imports, Post has hiked its pork import forecast to 425,000 MT for 2021. Meanwhile, sustained supply constraints lead to Post lowering its chicken import forecast to 330,000 MT.



Production

PORK

Post maintains 2021 pork production at 1 million metric tons (MT) carcass weight equivalent (CWE), in line with current data and discussions with industry contacts. African Swine Fever (ASF) remains a challenge to the Philippine hog sector, especially in the key producing provinces of Luzon while also spreading to previously ASF-free areas of Visayas and Mindanao. The latest report by the Philippine Statistics Authority (PSA) notes that total pork production declined 25.8 percent from January to March 2021 compared to the same period in 2020 (295,000 MT CWE and 398,000 MT CWE, respectively). As a result, regions with the largest production during the quarter were Central Visayas, Northern Mindanao, and Western Visayas. Central Luzon, historically the nation's top pork producer, plunged 76 percent. CALARBAZON, historically the second largest producer, dropped 50 percent.

Industry contacts report the decline in local production has stabilized while future prospects remain tentative. DA reports indicate a decline in active ASF cases, although many parts of the country remain categorized as infected (see ASF Zoning Status Map below). As some attempts to repopulate are being made, producers have generally remained cautious absent a commercially-available vaccine, which remains in trial.





Philippine government support to hog raisers

To encourage production, the Philippine Department of Agriculture (DA) launched a P29.6 billion (\$610 million) twin program focused on hog repopulation and facilitating hog raisers to return to business, while also strengthening biosecurity to control the spread of the hog virus. The programs are named the Integrated National Swine Production Initiatives for Recovery and Expansion (INSPIRE) and Bantay ASF sa Barangay (translation: protecting the neighborhood from ASF) or BABay ASF (translation: Goodbye ASF). The INSPIRE program has an initial funding of P600 million (\$12.37 million) to accelerate repopulation efforts and ensure availability, accessibility, and affordability of pork and pork products. The program has three components: calibrated repopulation and swine livelihood enterprise; establishment of breeding animal multiplier farms; and intensive and modernized production. BABay ASF, a local government-led program to curb the spread of ASF, will have an initial allocation of P1.5 billion (\$30.9 million). To encourage backyard and semi-commercial raisers in virus-free areas, the DA Agricultural Credit Policy Council will offer a P500 million (\$10.3 million) loan program, without interest, payable in three to five years. A majority of the funding will go to soft loans via the Land Bank of the Philippines and the Development Bank of the Philippines, which will be allocated P15 billion and P12 billion (\$308 million and \$247 million, respectively) for commercial operators.

On May 10, 2021, President Duterte signed <u>Proclamation No. 1143</u>, <u>Series of 2021</u>, declaring a *State of Calamity* due to ASF, and which authorizes additional funds and other resources to combat the disease, address the supply deficit, and reduce retail pork prices. The proclamation calls for a collective effort across government, as well as law enforcement agencies, to restore normalcy to the hog sector. The *State of Calamity* remains in effect for one year.


African Swine Fever Zoning Status

Inventory

As inventories of frozen pork in accredited cold storages have recovered to historical levels, pressures are intensifying on these facilities to ensure they now supply markets in the absence of freshly slaughtered domestic pork.

Prices

Following a rapid run up in prices tied directly to the disappearance of local pork production and thereafter moves by the government to modify market access in an attempt to arrest continued pork inflation, prices have stabilized, though still remain near all-time highs (see Trade).

Trade

Post raises 2021 imports to 425,000 MT, 21 percent higher than the USDA official forecast of 350,000 MT, based on trade trends and improved market access. On June 26, 2021, DA released the guidelines for the Minimum Access Volume (MAV) or tariff-rate quota for pork, specifying how the additional volume of 200,000 MT (authorized via Executive Order No. 133) will be implemented. Up to 70 percent of the additional MAV (i.e., 140,000 MT) will be available from July to October 2021, with the remaining 30 percent (60,000 MT) eligible from November 2021 through January 2022. MAV Import Clearances will be allocated on a first come, first served basis. See the corresponding report for more information on the latest guidelines.

As previously reported, <u>Executive Order 134</u> significantly lowered Most Favored Nation (MFN) rate tariffs for both in- and out-quota pork imports. <u>EO 128</u> had first set tariffs at lower rates from April 9 until May 18, until EO 134 repealed EO 128 and raised tariffs by 5 percentage points. Through April 2021, foreign pork supplies reached 195,300 MT, up 400 percent year-over-year.



Production


Post lowers USDA's 2021 chicken meat production forecast from 1.36 to 1.33 million MT in line with industry and government forecasts. According to the <u>latest PSA report</u>, chicken production was 11 percent lower year-over-year in the first quarter of 2021.

Inventory

Inventories of chicken meat in accredited cold storages, excluding MDM, have recovered but will increasingly have to compete with imported pork for limited space through at least 2021.

Prices

Chicken price movements have remained rather inconsistent given the varying changes to COVID-19 quarantine interventions, which continue to impact consumer purchasing power and producer market signals.

Trade

Post adjusts the 2021 official forecast of 350,000 MT to 330,000 MT on increasingly stressed supply chains. While official trade data remains mixed, Philippine meat processors, which account for the majority of poultry meat imports, have stressed difficulties sourcing mechanically deboned meat (MDM) as long as European supplies remain restricted.
