Report Highlights:

On July 24, 2017, Thailand and New Zealand reached an agreement to increase market access for New Zealand dairy exports to Thailand. Thailand's total import of dairy products in 2016 was \$154 million dollars with 13 percent originating from the United States.

General Information:

New Zealand Gains Additional Dairy Market Access in Thailand

On July 24, 2017, Thailand and New Zealand reached an agreement to increase market access for New Zealand dairy exports to Thailand. This agreement stills requires ratification by the Thai National Legislative Assembly. Once ratified, the 2005 Thailand-New Zealand Closer Economic Partnership Agreement (TNZCEP) will be amended to increase the volume of certain New Zealand dairy products that can be exported to Thailand under preferential tariff rates. New Zealand's volume cap for preferential tariffs will increase by 20 percent for its whey products and an additional 10 percent for cheese and anhydrous milk fat products. Thailand's total import of dairy products in 2016 was \$154 million with 13 percent originating from the United States.
