Market Opportunities for U.S. Pea and Lentils in Peru

Report Highlights:

Peru's calendar year (CY) 2015 pea and lentil imports are forecast at 73,000 metric tons (MT), up 16 percent compared to 2014. U.S.-origin pea and lentil imports are estimated at 28,000 MT, up nine percent compared to 2013. In terms of value, Peruvian imports of U.S.-origin peas and lentils have jumped from \$10 million in CY 2008 to nearly \$23 million in 2013, growing with a compound annual growth rate of 17 percent during 2008-13.

General Information:

Despite economic growth slowing to about 2.8 percent during 2014 (compared to average annual growth of 6.6 percent in 2010-13), Peru offers U.S. exporters of pulses excellent possibilities. Peas and lentils in particular offer opportunities.

Peru's total pulse imports have increased steadily in recent years. Peru's calendar year (CY) 2015 pea and lentil imports are forecast at 73,000 metric tons (MT), up 16 percent compared to 2014. U.S.-origin pea and lentil imports are estimated at 28,000 MT, up 9 percent compared to 2013. In terms of value, Peruvian imports of U.S.-origin peas and lentils have jumped from \$10 million in CY 2008 to nearly \$23 million in 2013, growing with a compound annual growth rate of 17 percent during 2008-13.

We attribute growth to the combination of increased recognition of U.S. product quality and rising domestic demand for a wholesome source of inexpensive protein. Domestic Peruvian production is also insufficient to meet current demand. Currently U.S.-origin product enjoys a market share of 38 percent.

Required Documentation

Prior to product shipment, the importer must request an import permit from SENASA (Peru's sanitary authority). The exporter must provide to the importer with a sanitary/phyto-sanitary certificate from the country-of-origin. The U.S. Department of Agriculture's (USDA) Animal and Plant Health Inspection Service (APHIS) is the competent U.S. authority for issuing sanitary/phyto-sanitary certificates. USDA's Grain Inspection, Packers and Stockyards Administration (GIPSA) supervises the export of grains, oilseeds, and related commodities.

Key Market Features

- Pulses are a critical part of the Peruvian diet.
- Healthier eating habits are being promoted in Peruvian gastronomy, boosting the consumption of peas/lentils.
- Peas are the most consumed pulse, 3.8 kilogram/person per annum year. Beans follow at 2.6 kilogram/person and lentils come in third at 1.8 kilogram/person.
- The U.S.-Peru Trade Promotion Agreement (PTPA) grants duty-free access.
- Expansion of food retail channel in Lima and provinces, as well as private label brands.
- A price sensitive market.
