Food prices in Poland on the rise

Report Highlights:

During the January – April 2011 period, prices on consumer goods and services increased 2.9 percent, with food prices rising by 5.8 percent and transportation services by 4.3 percent. The annual consumer price index in April stood at 4.5 percent, up from March's 4.3 percent (year-on-year). This level exceeds the upper limit of 2.5 percent set for inflation targeted by the Monetary Policy Council. When taking into consideration lower global supplies, falling food reserve levels, and increasing costs of production, pressure will remain on food prices for the foreseeable future.

Poland's Central Statistic Office (CSO) is responsible for reporting on prices of consumer goods and services. According to CSO data, in 2010 food prices increased by an average of 5 percent, led by bakery flour (50 percent), pasta (40 percent), and bread (20 percent). The first couple months of 2011 witnessed further price increase though the influx of grain onto the market tempered the rate of rise.

CSO data published in May 2011 showed the price index rose by 0.5 percent in April as compared to March. Different groups of products characterize different dynamics; however, the largest impact on the consumer price index again was food, where prices rose by 0.9 percent, and services related to transportation, where prices rose by 1.7 percent. Within the food category, price rose fastest for sugar (4.7 percent) and vegetables (2.7 percent). Within the meat category, price rose for pig meat (1.7 percent), poultry (1.4 percent), beef (1.3 percent), and cold meats (0.5 percent). Price increases were also reported for April for fish (0.9 percent), milk and butter (0.7 percent), milling and pasta preparations (0.6 percent), bread (0.5 percent), and cheese (0.4 percent). Industry estimates are that in the first half of 2011 bread prices will increase by 10-15 percent, but will stabilize in the second half as grain supplies become more readily available. However, grain prices are not the only factor in the most recent food prices increases. Other factors include: rising transportation costs, increase in Value Added Tax (equivalent of Sales tax in the United States) for flour from 3 to 5 percent, and market speculation leading to some hording of basic commodities (like sugar

Officially, the Ministry of Agriculture estimates that in 2011 food prices will increase by no more than 5 percent.

Ministry comments reflect a view that market speculation is driving food price increases. Due to the importance of the issue, late last year Poland's Prime Minister appointed an inter-ministerial team review relationships between farmers, processors, and trade. That team developed and released a so-called "Code of good practices," yet to be adopted by the largest stores and supermarkets. Meanwhile the Ministry of Agriculture continues to focus attention on what it deems the primary cause for rising food prices - speculation driven by high trader margins, noting it's easier to blame climate change, weather events, increased consumption in China or India or use of agricultural raw materials for renewable energy as the culprit.

"Looking at the statistics of last year, grain production fell by 2 percent and wheat prices increased by

150-200 percent" noted the Ministry. It has to be noted that the grain sector disagrees with the official production data for 2010/11 and reports production lower thus the reason for increasing prices.
