Export prices were steady this week as most rice business remained inactive due to the Luna New Year holidays. Also, traders are awaiting the new tender for 569,116 metric tons of Government stocks on February 16-17, 2016. The tender will consist of an open tender for 204,998 metric tons of food-grade rice on February 16. Most of the food-grade rice will be glutinous rice, broken white rice, and fragrant rice. The other tender on February 17 will be for 364,118 metric tons of non-food grade rice for industrial uses and animal feed. Around 80 percent of non-food grade rice will be broken white rice from MY2011/12 and MY2012/13 pledging program. The only eligible bidders in this second tender will be from non-food and manufacturing sectors including (but not limited to) feed mills, ethanol producers, plastic manufacturers and power generator companies.

Rice Export Update

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for February 1-7, 2016 totaled 48,008 metric tons, down 38,759 metric tons from the previous week, and down 33,681 metric tons from the four-week moving average of 81,689 metric tons (Table 2). Rice exports from January 1 – February 7, 2016 totaled 399,955 metric tons, up 36 percent from the previous week.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FAS/BKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
