Report Highlights:

TH6031 – Export prices increased 1 to 2 percent with exporters fulfilling outstanding shipments under the Government-to-Government agreement with China. The Government will issue new tenders for 642,498 metric tons of food and non-food grade rice stocks on March 30-31.

Export prices increased 1 to 2 percent as exporters are seeking supplies of new-crop white rice for the shipments to China under the Government-to-Government agreement. Thai and Chinese Government settled the last allotment of 130,000 metric tons of new-crop 5% grade white rice under the old Government-to-Government agreement of one million metric tons signed in 2014. The prices are reportedly \$400/MT (FOB, 50 kilogram bag) and \$405/MT (25 kilogram bag). The delivery will take place during March to April 2016.

The Government will issue a new tender for 642,498 metric tons of its stocks on March 30-31, 2015. The tender will consist of an open tender for 418,736 metric tons of food-grade rice on March 30. Around 70 percent of food-grade rice will be 5% grade white rice with the balance being 10% grade white rice, and glutinous rice. The other tender on March 31 will be for 223,762 metric tons of non-food grade rice for industrial uses and animal feed. Around 40 percent of non-food grade rice will be broken white rice.

Rice Export Update

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for March 14-20, 2016 totaled 58,825 metric tons, down 8,762 metric tons from the previous week, and down 10,450 metric tons from the four-week moving average of 69,275 metric tons (Table 2). Rice exports from January 1 – March 20, 2016 totaled 923,287 metric tons, up 18 percent from the previous week.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FAS/BKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
