Export prices increased slightly mainly due to the strengthening of the Thai baht (35.9 baht/US\$ last week to 35.2 baht/US\$). Some exporters are keeping their quotations unchanged as they await the details of the new public tender which will be announced during the week of March 14. Traders expect that the Government will have some food-grade 5% grade white rice available in the tender, in contrast to last tender which mainly consisted of food-grade glutinous rice. The Thai Government is negotiating with China to increase the prices for the last shipment of new-

The Thai Government is negotiating with China to increase the prices for the last shipment of new-crop 5% grade white rice (100,000 metric tons) under the one-million-metric-ton Government-to-Government agreement signed by the previous Government in 2014. The prices are considered to be too low at \$360/MT compared to around \$405 – 410/MT in the past shipments. This will be a benchmark price for the shipments of the 2-million-metric-ton Government-to-Government agreement signed by the military Government in 2015 for delivery in 2016 and 2017.

#### **Rice Export Update**

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for February 29 – March 6, 2016 totaled 99,027 metric tons, up 47,367 metric tons from the previous week, and 47 metric tons from the four-week moving average of 98,980 metric tons (Table 2). Rice exports from January 1 – March 6, 2016 totaled 795,876 metric tons, up 29 percent from the previous week.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FAS/BKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
