Report Highlights:

TH5072 – Export prices declined 2 to 3 percent in anticipation of the sales of government stocks through a public tender for around 1.1 million metric tons on June 15. The Government announced floor price for bids for 5% grade white rice which are 10-25 percent below current market prices.

Export prices declined 2 to 3 percent from the previous week in anticipation of the sales of government stocks. The Government will issue a public tender for about 1.1 million metric tons on June 15, 2015. The tender will mainly consist of 0.6 million metric tons of 5% grade white rice from MY2011/12 – MY2013/14 rice stocks and 0.3 million metric tons of broken white rice (A1 Super grade) from MY2011/12 – MY2012/13 rice stocks (Table 2). The remainder will mainly be comprised of 10% grade glutinous rice and white rice. The Government determined floor prices for bids of 5% grade white rice range between 8,500 to 10,000 baht per metric tons (\$252-297/MT) which are approximately 10-25 percent below current market prices levels (11,500 baht per metric tons (\$340/MT)). This is the first time the Government has announced the internally establish floor prices that will be considered in the tender. The result of the tender will be announced on June 16.

Regarding the Philippines National Food Authority (NFA)'s tender for 250,000 metric tons of 25% grade new-crop white rice on June 5, trade sources indicated that Thailand could not compete on price with Vietnam which offered the lowest bids at around \$410/MT, CIF. Presently, export prices of Vietnamese 25% grade white rice are offered at approximately \$335/MT (FOB) which is \$10/MT cheaper than Thai rice.

Rice Export Update

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for June 1-7 2015 totaled 59,677 metric tons, down 2,663 metric tons from the previous week and down 9,388 metric tons from the four-week moving average of 69,065 metric tons (Table 3). Rice exports (excluding premium white and fragrant rice) from January 1-June 7, 2015, totaled 1,594,615 metric tons, down 17 percent from the same period last year.

Total rice exports from January to April 2015 totaled 2,826,561 million metric tons, down 4 percent from the same period last year (See GAIN Report – TH5069 Grain and Feed Update, May 2015).

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FASBKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
