## Weekly Rice Price Update

### **Report Highlights:**

TH5091 – Export prices increased around 1 percent as upward pressure on domestic prices more than offset the weakening Thai baht. The Government will likely begin to issue public tenders for non-food grade rice next week.

Despite the weakening of Thai baht (34.4 Baht/US\$ compared to 33.9 Baht/US\$), export prices increased around 1 percent from the previous week. This is due to the upward pressure on domestic prices caused by the on-going drought situation. Domestic prices of current-crop white rice (5% grade) increased to 12,450 baht per metric tons (\$362/MT), up approximately 2 percent from the previous week. The Government revised up its estimate of drought damage areas in the central plains to around 1.4 million rai (0.22 million hectares), compared to the previous estimate of around 0.9 million rai (0.14 million hectares). This is due to the government decision to block the irrigation for farming since July 16 in order to save water for household consumption purposes until mid-August. This will primarily affected main-crop rice in the central plains which has been planted in June. Since May 2015, around 4.9 million rai (0.8 million hectares) have reportedly been planted in the lower northern region and the central plains.

The Government announced that it will likely begin to issue new public tenders for non-food grade rice stocks of 1.29 million metric tons in the week of July 27. This rice is expected to be used primarily for ethanol production. Around 0.5 million metric tons of rice are likely to be substituted for cassava in ethanol production in the second half of 2015. This will account for around half of the annual demand for cassava in ethanol production (See GAIN Report: TH5085 – Biofuel Annual 2015, July 2015).

#### **Rice Export Update**

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for July 13-19, 2015 totaled 65,304 metric tons, down 22,540 metric tons from the previous week and down 16,702 metric tons from the four-week moving average of 82,006 metric tons (Table 2). Rice exports (excluding premium white and fragrant rice) from January 1 – July 19, 2015, totaled 2,132,065 metric tons, down 19 percent from the same period last year.

Total rice exports from January to May 2015 totaled 3,772,158 metric tons, down 1.4 percent from the same period last year (See GAIN Report – TH5082 Grain and Feed Update, June 2015).

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FAS'BKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
