Domestic and export prices declined slightly from the previous week, particularly for parboiled rice as new off-season crop supplies come onto the market. Meanwhile, the MY2012/13 Off-Season Paddy Pledging Program has not been finalized as the National Rice Policy Committee's meeting has been postponed until mid-March. Intervention prices for the rice program may have to be revised due to limited financial resources caused by the delay in government rice stock sales. However, the Ministry of Commerce is committed to selling additional rice stocks worth 180 billion baht (\$6 billion) to repay the Bank for Agriculture and Agricultural Cooperatives (BAAC) by the end of the year. As of February 28, 2013 the BAAC has received only 86 billion baht (\$2.9 billion) from the sale of government rice stocks since April 2012, most of which are reportedly domestic sales.

The current MY2012/13 Main-Crop Paddy Pledging Program has preliminarily received pledges of approximately 10.5 million metric tons (6.8 million metric tons milled equivalent, as of February 17, 2013). The pledges consist of 6.2 million metric tons of white rice paddy, 3.7 million metric tons of

fragrant rice paddy, and 0.6 million metric tons of glutinous rice paddy.

Rice Export Update

Unofficial rice exports (excluding fragrant rice) for February 25 – March 3, 2013 totaled 89,843 metric tons, down 7,870 metric tons from the previous week, and up 2,738 metric tons from the four- week moving average of 87,105 metric tons. Exports of white and parboiled rice from January 1 – March 3, 2013 totaled 770,165 metric tons, down 1.7 percent (783,808 metric tons) from the same period last year.

Total rice exports (including fragrant rice) from January 1 - 31, 2013 amounted to 573,853 metric tons, up 30.5 percent from the same period last year.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. The authority to report fragrant rice exports was moved from the Thai Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice export data. FAS/RKK will report only official export numbers from the Board of Trade for non-fragrant and from the Office of Commodity Standards for fragrant rice when available, but the reader should bear in mind the difference between the data.
