Export prices increased approximately 1 percent as the Thai baht strengthened to 34.2 baht/USD, compared to 34.5 baht/USD from the previous week. On March 23, 2017, the Ministry of Commerce received qualified bids for approximately 2.1 million metric tons from 15 bidders on their 3.7 million metric ton non-food quality rice tender. The received bids averaged between 4,000 - 5,000 baht per metric ton (117 - 146 USD/MT) though several bids were significantly lower. Industry expects that the government will sell approximately 1.8 million metric tons, mainly to feed mills and swine farms who offered the highest bids. The results of the tender will be considered by the Sub-Committee on Rice Stock Release on March 28, 2017, and will be finalized by the National Rice Policy and Management Committee in early April 2017.

The government plans to issue a new tender for approximately 1.8 million metric tons of deteriorated rice for ethanol production in April 2017. Additionally, the remaining food-quality rice stocks of around 1.5 million metric tons will be retendered in May 2017, followed by the remaining non-food quality rice and deteriorated rice stocks in June and July 2017, respectively.

## **Rice Export Update**

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for March 20-26, 2017, totaled 52,942 metric tons, down 63,540 metric tons from the previous week, and down 79,260 metric tons from the four-week moving average of 132,202 metric tons (Table 2). Rice exports from January 1 – March 26, 2017, totaled 1,771,906 metric tons.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, during May 1, 2013 - December 18, 2016, export data did not include 25% - 100% grade white rice exports as the reporting authority was moved from the Thai Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official export data. FAS/BKK reports only the official export numbers available from the Board of Trade of Thailand. The reader should bear in mind these differences when comparing historical data with current data.
