Export prices were virtually unchanged from the previous week due to lack of new enquiries. Traders are awaiting new tenders for government stocks which will be issued on July 25, 2016. The government announced that it will issue three tenders totaling 3.8 million metric tons, up from two tenders for 2.6 million metric tons reported last week. The first tender for 2.2 million metric tons will be contingent for export only as eligible bidders are required to have export orders from their foreign buyers. It will mainly consist of 5% grade white rice and broken rice (A1 Super) from carry-over stocks under the MY2012/13 and MY2013/14 rice pledging programs. The second one will be a public tender for 0.7 million metric of food-grade rice for domestic and export market. Meanwhile, the last tender for 0.9 million metric tons will be industrial uses, particularly for feed and ethanol industries.

Rice Export Update

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for July 4-10, 2016 totaled 39,776 metric tons, down 18,156 metric tons from the previous week and down 19,120 metric tons from the four-week moving average of 58,896 metric tons (Table 2). Rice exports from January 1 – July 10, 2016 totaled 1,870,118 metric tons, down 8 percent from the same period last year.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FAS/BKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
