#### **Report Highlights:**

TH4082 – Export prices increased 1 to 2 percent due to tighter domestic supplies. The Thai government signed a government-to-government contract with the Philippines for 300,000 metric tons of white rice.

Export prices increased approximately 1 to 2 percent from the previous week due to tighter domestic supplies during the end of the 2013/14 marketing season and limited sales of the government stocks. Exporters are actively executing the shipments of new-crop white rice to China and Indonesia under the government-to-government contracts. Also, the Thai government signed a government-to-government contract with the Philippines for 300,000 metric tons of new-crop 25 percent grade white rice last week. This is the first government-to-government contract with the Philippines in the past ten years. The prices are \$475/MT (CIF). The deliveries will take place during October – December 2014. The shipments are subcontracted to rice exporters as with other government-to-government contracts. The government is reportedly considering offering \$25-30/MT export subsidies for qualified exporters. The subsidies will be paid in rice from the government stocks.

#### **Rice Export Update**

Unofficial preliminary rice exports (excluding premium white and fragrant rice) for September 15-21, 2014 totaled 155,754 metric tons, up 45,891 metric tons from the previous week and up 29,577 metric tons from the four-week moving average of 126,177 metric tons (Table 2). Rice exports from January 1 – September 21, 2014, totaled 3,735,739 metric tons, up 56 percent from the same period last year.

Note on data: Export figures since March 22, 2002, do not include fragrant rice. In addition, starting May 1, 2013, the data will not include 100% - 25% grade white rice exports. The reporting authority was moved from the That Board of Trade to the Ministry of Commerce's Office of Commodity Standards, which does not release official fragrant rice and white rice (100%-25% grades) export data. FASBKK will report only official export numbers available from the Board of Trade of Thatland. The reader should bear in mind the difference between the data.
