# Soybean Meal Import Duty Fixed at 5 Percent

#### **Report Highlights:**

Resolution #1019 of December 16, 2009, replaced the expired temporary 5 percent import duty on soybean meal with a 5 percent permanent one. The duty covers contracts initiated December 6, 2009. This duty equals the newly established Customs Union duty on soybean meal.

#### **General Information:**

The Government Resolution #1019 of December 16 "On Approval of Soybean Meal Import Custom Duty" fixed the import duty on soybean meal (Customs Code 2304 00 000 1) at 5 percent of customs value. The Resolution comes to force on December 21, 2009, the day of its publication in Rossiyskaya Gazeta, but applies to legal relations created beginning December 6, 2009. The 5 percent import duty, as temporary, was in force from March 6 to December 6, 2009 (9 months) in accord with the Russian Government Resolution #70 of January 31, 2009 (GAIN report RS9005 \_ Oilseeds and Products \_ New 5 Percent Import Duty on Soybean Meal).

The 5 percent import duty on soybean meal was initiated by the Russian oilseeds crushers, particularly company Sodruzhestvo, which has been rapidly increasing imports and crushing of soybeans in Russia since 2008. This duty has been agreed upon within the Customs Union (Russia, Belarus, Kazakhstan) in November 2009. The 5 percent soybean meal import duty has affected imports of soybean meal, and according to some analysts, led to monopolization of Russia's soybean meal market by one company, and limited Russian feed consumers' choice of soybean meal. Meantime, Russia's duty free imports of soybeans have increased along with rapidly increasing domestic crushing. Argentina and Brazil, the major suppliers of cheap soybean meal to Russia, were mostly affected by 5 percent import duty, but Brazil compensated it by increasing its duty-free soybean shipments to Russia. In order to facilitate the soybean trade, Russia has recently signed a phytosanitary-veterinary agreement on shipments of soybeans from Brazil to Russia (GAIN report RS9078 \_ Market Promotion/Competition, Oilseeds and Products, Grain and Feed \_ Russia Updated Phytosanitary Memorandums with Brazil).

The table below shows changes in Russia's imports of soybeans and soybean meal.

# Resolution of the Government of the Russian Federation #1019 of December 16, 2009 "On Approval of Soybean Meal Import Duty"

The Government of the Russian Federation decrees the following:

- 1. As partial change to the Customs Tariff of the Russian Federation, approved by the Resolution of the Government of the Russian Federation #718 of November 27, 2006 "On the Customs Tariff of the Russian Federation and the Commodity Nomenclature for the Foreign Economic Activity" (Collection of legislative acts of the Russian Federation, 2006, #50, article 5341; 2009, #6, article 742), to approve the import customs duty on soybean meal (TN VED Code of the Russian Federation [1] 2304 00 000 1) at 5 percent of the customs value. For application of this import customs duty the commodity is defined exclusively by the TN VED Code of Russia. The name of commodity is given only for convenience of reference.
- 2. The present Resolution comes into force from the day of its official publication and applies to legal relations created as from the date of December 6, 2009.
