Report Highlights:

On July 23, 2024, the State Council Tariff Commission (SCTC) announced the extension of Section 301 retaliatory tariff exclusions on 12 agricultural tariff lines, notably certain logs/lumber, whey for feed use, fishmeal for feed use, and alfalfa through February 28, 2025. The 12 agricultural tariff lines are part of a list of 95 commodities which were scheduled to have their Section 301 tariff exclusions end on July 31, 2024. This is the fifteenth extension of tariff exclusions for different lists of commodities with various exclusion periods. This report contains an unofficial translation of the SCTC announcement and a list of agricultural products subject to the tariff exclusion.

BACKGROUND

On July 23, 2024, the Ministry of Finance published on its website a SCTC announcement that extends the retaliatory tariff exclusion period for a total of 95 commodities through February 28, 2025. The affected agricultural-related products include certain logs and lumber, alfalfa, whey for feed use, and shrimp/prawns for breeding use. This is the fifteenth time the PRC has extended the tariff exclusion period for these commodities.

BEGIN TRANSLATION

Announcement of the State Council Tariff Commission on the 15th Extension of the Exclusion List of the U.S. Products Imposed with Additional Tariffs SCTC Announcement No. 6 (2024) July 20, 2024

According to the Announcement of the State Council Tariff Commission on the 13th Extension of the Exclusion List of the U.S. Products Imposed with Additional Tariffs (SCTC Announcement No. 11 [2023]), the 13th extension of the exclusion list of the U.S. products imposed with additional tariffs will expire on July 31, 2024. The State Council Tariff Commission has decided, in accordance with procedures, to extend the exclusion period for related commodities. The relevant matters are hereby announced as follows:

From August 1, 2024 to February 28, 2025, the commodities listed in the Annex will continue to be excluded from the retaliatory tariffs against U.S. Section 301 Measures.
