Report Highlights:

TH0136 Domestic and export prices for most grades of rice remained unchanged from the previous week, except for parboiled rice prices which continued to increase. On September 22, Japan resumed its rice import tender to meet WTO minimum access commitments by allocating 12,000 tons of 100% B grade white rice to Thai rice exporters whose bidding prices were lower than market prices.

Domestic and export prices for most grades of white rice remained unchanged from the previous week, except for parboiled rice prices which continued to increase. African and Middle East countries continue making enquiries on Thai parboiled rice for November – December deliveries as exportable supplies of Indian parboiled rice remain limited (the Indian government has yet to officially lift the ban on non-basmati rice exports, although it's assumed that some parboiled rice is making its way into the world market). Meanwhile, on September 22, Japan resumed its rice import tenders to meet its WTO minimum access requirements by allocating 12,000 tons of 100% B grade white rice to Thai rice exporters whose bidding prices were \$480/MT, 4-5 percent lower than current market prices. It is noteworthy to mention that the bid winners are those exporters who were granted Thai government stocks at favorable prices in August.

The weekly benchmark prices for white rice for September 27 – October 3, increased by 1.8 percent. As such, farmers will receive lower compensation compared to the previous week. Farmers that sell their supplies this week will not attain insurance prices, as compensation will fall short due to higher compensation prices over market prices.

Rice Export Update

Unofficial rice exports (excluding fragrant rice) for Sep 20-26, 2010 totaled 165,570 tons, up 17,855 tons from the previous week, and up 24,246 tons from the four-week moving average of 141,324 tons. Exports of white rice and parboiled rice during January 1 – September 26, 2010 totaled 4,370,362 tons, down 2.0 percent from 4,458,898 tons in the previous year.

c' Strating Apr. 26, 2010 the benchmark prices will be based on average wholesales price of last week in Bangkok.

According to the Department of Foreign trade, Ministry of Commerce, total rice exports (including fragrant rice) during January 1 – September 20, 2010 amounted to 5,807,031 tons, down 7.5 percent from 6,275,846 tons in the previous year.

FAS/BKK will report only official export numbers from the Board of Trade for non-fragrant and from the Office of Commodity Standards for fragrant rice when available, but the reader should bear in mind the difference between the data.
