Tourism Authority of Thailand Reports Arrivals up 13 Percent in First Half of 2010

In spite of the sharp declines in arrivals during the political crisis months of May and June 2010, international arrivals were enjoyed a 13.70 percent increase for the first half of 2010 as compared to 2009. Figures for January - June 2010 totaled 7.5 million arrivals up from 6.6 million in the same period of 2009. The Tourism Authority of Thailand is expects to meet its goal of attracting 14.5 million arrivals in 2010, as promotional programs have been responsible for this uptick. Consumption of U.S. wines, seafood and beef are largely driven by the tourist industry.

Thailand Considering Excluding Alcohol Beverages in Trade Agreements

According to the Deputy Commerce Minister, Mr. Alongkorn Ponlaboot, the Thai government is considering to exclude alcohol beverages from existing and new free trade agreements, claiming that they are harmful to health and society. This might stall current attempts of a possible trade agreement with the EU, as the EU has stated that it will not engage in any negotiations if alcohol is excluded from from the agreement.

MARKET ACCESS UPDATE

Thailand Liberalizes Imports of Breeding Layer Chicks

On July 15, the Thai Cabinet agreed to liberalize imports of breeding layer chicks in an effort to address tight egg supplies. Prior to the Cabinet's agreement, imports of breeding chicks were administered by a government-appointed committee, the Committee on Layers and Egg Product Development Policy, which would set quotas on the imports of layer chicks, i.e. 405,721 birds in 2010, in an effort to sustain prices. According to the Department of Livestock Development, Thailand imported 259,250 birds of layer breeding stocks in 2008, including 14,500 birds from the U.S. valued at 1.84 million baht (\$53,730).

Relocation of Asia Aquaculture Conference 2010 from Thailand to Philippines

The programs have been specifically tailored for the Southeast Asian Region.

In addition to highlighting the advantages of DDGS (Distiller's Dried Grains with Soluble) in poultry nutrition, the presentation will include updates on DDGS supplies and current market and trade trade snapshots.
