### **Transitional Import Tariffs for Armenia in EAEU until 2022**

**Report Highlights:**

As part of its accession to the Eurasian Economic Union [1] (EAEU), Armenia has committed to eventually adopt the unified tariff schedule of the EAEU. This report contains an unofficial translation of the agriculture-related portion of Armenia's EAEU import tariff commitments. Until 2022, Armenia will be able to apply customs duties that are different from the EAEU tariff rates for certain agricultural items (e.g., some meat and poultry items, dairy products, fruits and vegetables, tea, grains, starches, vegetable oils, margarine; some prepared food items, pet food, tobacco, glycerol, and gelatin). By 2022, all of the above-mentioned items, with the exception of some fresh and dried fruits, will see import tariff increases, with meat and poultry seeing the greatest change.

## General Information

On December 10, 2014, the Eurasian Economic Commission (EEC), the working body of the Armenia-Belarus-Kazakhstan-Russia [Eurasian Economic Union](#) (EAEU), issued EEC Council decision No. 113 (see below) which approves a list of transitional import tariff rates for Armenia until 2022:

- [EEC Council Decision No. 113](#) “On Approval of the List of Goods and Rates that shall be subject to a Transition Period during which the Republic of Armenia shall Apply the Rate of Import Customs Duties Differing from the Rates of the Unified Customs Tariff of the Eurasian Economic Union” (original in [Russian](#))

As part of its EAEU accession, Armenia has committed to eventually adopt the unified tariff schedule of the EAEU. According to decision No. 113, Armenia will be able to apply customs duties that are different from the EAEU tariff rates until 2022. The list includes a number of agricultural items, such as some beef, pork, poultry, and dairy products; seed potatoes and peas; olives; fresh and dried fruits; some tea items; grains, including wheat and rice; starches, vegetable oils, margarine; some prepared food items, including baby food; pet food; tobacco; glycerol; and gelatin. However, by 2022, all of the above-mentioned items, with the exception of some fresh and dried fruits, will see import tariff increases, with meat and poultry seeing the greatest change.

This report contains an unofficial translation of EEC Council decision No. 113 and the agriculture-related portion of the tariff schedule approved by this decision.

The [Treaty on Accession of the Republic of Armenia to the Eurasian Economic Union Treaty of May 29, 2014](#) (original in [Russian](#)) contains a provision that the Republic of Armenia shall ensure that goods imported into Armenia at lower tariffs than the unified EAEU tariff, will be used only in the territory of Armenia and will not be re-exported to the other EAEU member-states without payment of the difference between the respective import tariff rates. Moreover, the Treaty also contains a provision that Belarus, Kazakhstan and Russia shall have the right to establish a procedure for handling the arrival of such goods into their territory.

**On Approval of the List of Goods and Rates that shall be subject to a Transition Period during which the Republic of Armenia shall Apply the Rate of Import Customs Duties Differing from the Rates of the Unified Customs Tariff of the Eurasian Economic Union**

In connection with the signing of the October 10, 2014 Treaty of Accession of the Republic of Armenia to the Treaty on the Eurasian Economic Union of May 29, 2014, subject to paragraph 40 of Annex No. 3 to the said Treaty and in accordance with Article 42 of the Treaty on the Eurasian Economic Union of May 29, 2014, the Council of the Eurasian Economic Commission **has decided:**

1. To approve the attached List of goods and rates that shall be subject to a transition period during which the republic of Armenia shall apply the rate of import customs duties differing from the rates of the unified customs tariff of the Eurasian Economic Union.

2. This decision shall enter into force after 10 calendar days from the date of its official publication, but not earlier than the date of entry into force of the Treaty of 10 October 2014 on the Accession of the Republic of Armenia to the Treaty on the Eurasian Economic Union on May 29, 2014.
