**Report Highlights:**

The United Kingdom (UK) recently announced a number of voluntary tariff suspensions for agricultural and non-agricultural products, including around 70 new agricultural product suspensions. The following report provides an overview on the tariff suspensions and expiry dates. These suspensions are applicable for all countries and without limitations on the volume of exports.

## **Summary**

On [March 26](#) and [March 17](#), the United Kingdom (UK) updated its voluntary tariff suspension for agricultural and non-agricultural products commencing on April 11, 2024. The UK's tariff suspensions announcements are voluntary temporary reductions of the UK's Most-Favored Nation (MFN) applied rate. On March 17, the UK extended post-Brexit tariff suspensions, which were due to expire on December 31, 2024, until December 31, 2028. On March 26, the UK published details on additional tariff suspensions, including approximately 70 agricultural products, to be applied through June 30, 2026. These suspensions are applicable for all countries and without limitations on the volume of exports.

## **Process**

Tariffs suspended under the March 26 announcement followed an application process where stakeholders could apply for tariff suspensions on specific products. The application process was published on June 12, 2023, on [Gov.UK](#) and completed on August 6, 2023. A list of requested tariff suspensions can be found [here](#). This process is expected to be repeated every two years or as otherwise notified.

The UK's tariff suspensions announcements are voluntary temporary reductions of the UK's Most-Favored Nation (MFN) applied tariff rate. These suspensions are time-limited and set to a 0 percent tariff rate. The UK maintains the legal right to revert to the UK's published WTO MFN rate at its discretion. Should there be a change of government, this policy may be reviewed.

## **Outcome and implications**

The following table includes a selected group of tariff suspensions and associated U.S. export values. This list only provides a sampling of the overall tariff suspensions, including some products which have previously had significant tariffs.

**NOTE:** The export values listed in the table below are based on U.S. exports to the UK of products at the four-digit harmonized tariff schedule (HS4) level. The description column is associated with the description provided by applicants requesting tariff suspensions. The final column includes those businesses who submitted applications and consented to publication of their names.

**What this means for the future**

This round of tariff suspensions adds to the already significant [list of pre-existing tariff suspensions](#). The current UK government is tending towards trade liberalization, and is unlikely to lift these suspensions, especially as food inflation remains and important concern for the government. A consistent two-year review of tariff suspensions, evidence by the March 26 announcement, may impact the broader UK applied MFN review process. But, this process also provides greater opportunities for stakeholders, importers, processors and UK producers to apply more consistently for tariff deductions.
