**Report Highlights:**

On October 20, 2023, Jordan notified the World Trade Organization (WTO) of a new Sanitary and Phytosanitary (SPS) measure on poultry meat imports (G/SPS/N/JOR/44). The measure requires poultry meat to be produced using feed free from animal powders of ruminant origin. Comments on this measure are due no later than December 19, 2023, and the proposed date of entry into force for the measure is February 20, 2024.

**General Information:**

On October 20, 2023, Jordan notified the World Trade Organization (WTO) of a new Sanitary and Phytosanitary (SPS) measure ([G/SPS/N/JOR/44](#) – a copy of which is also attached) that will apply to fresh, chilled, and frozen imports of meat and edible offal from poultry (i.e., HS codes 0105 and 0207). The measure requires poultry meat to be produced using feed free from animal powders of ruminant origin. Comments on this measure are due no later than December 19, 2023, and the proposed date of entry into force is February 20, 2024.

Jordan cites Article 11.4.1 of Chapter 11.4, Bovine Spongiform Encephalopathy of the Terrestrial Animal Health Code, as a relevant international standard. 
